## MESSAGE FROM HUGH BOYD



A Good Samaritan is someone who helps his neighbor in a time of need.

We, at IBEW Local 104, are blessed

to have many Good Samaritans in our membership, including lineman Ross Dugan.

On the morning of Feb. 7, Brother Dugan was driving home from work after finishing his night shift at the MBTA. While on Rt. 24 in Bridgewater, Mass., he witnessed a four-car crash and immediately pulled over to see if anyone needed help.

He was concerned, and rightly so, because when the crash occurred, it left a trail of fuel behind. Within moments, a spark ignited the gas and the fire chased one of the wrecked vehicles, igniting it with four passengers trapped inside, unable to open their doors or windows.

As he raced toward the burning car, Brother Dugan saw the passengers banging on the windows, unable to exit the fiery vehicle.

Not thinking about the dangers he was about to face, but only thinking of helping those poor souls trapped inside the burning car, Brother Dugan found the strength to rip out one of the vehicle's windows, which allowed three people to escape.

One man remained trapped inside though, as the raging fire intensified. By this time, the fire was too hot for Brother Dugan to approach the hole, which was formerly occupied by the window.

Inside the engulfed car, the last man moved into the front seat and tossed his arms out the hole, making one last

desperate attempt to save his life.

Brother Dugan, despite the intense inferno, stepped forward and tried to pull him out.

At that same time, another motorist who had seen the accident approached the vehicle with a fire extinguisher and s

with a fire extinguisher and sprayed a portion of the car, temporarily taming the flames near the hole.

This allowed Brother Dugan the opportunity to step up and grab the arms of the trapped man, whom he then pulled out of the car.

Fortunately, everyone in the vehicle survived with only minor injuries thanks to the unselfish action of Brother Dugan, who suffered second-degree burns to his face and hands.

We are all grateful he is on the road to a full-recovery, as his burns have healed enough to allow him to return to work.

After the rescue, Brother Dugan's heroic tale was told in the news and despite this attention, he has remained modest about the situation, which is a true testament to his humility.

The Boston Bruins Association recognized him as their Hero of the Month. They treated Brother Dugan and his daughter like Bruins' royalty by providing them with two tickets to a game, a game shirt and his daughter rode the Zamboni during one of the intermissions.

Furthermore, our own International Office is in the process of recognizing Brother Dugan's heroic actions.

On behalf of the IBEW Local 104 members and staff, we are extremely proud of Brother Dugan and we







are extremely thankful that he is recovering from his injuries.

The next opportunity for Local 104 to show our support for the project will be the week of April 1, 2019 in Farmington, ME for the DEP public hearings.

## MESSAGE FROM JASON BENTLEY



Brothers and Sisters.

I would like to talk about an incident that happened to our members in late November

2018. A transmission crew working in the Northern jurisdiction, changing out structures, had the line accidentally energized at full nominal voltage. Fortunately, our members had installed proper equipotential grounding and the line tripped after 8 milliseconds. The incident resulted in zero injuries.

This is the nightmare scenario that we all hear about yet have never seen. The world class training provided by NEAT, OSHE and our contractor partners was put to the test on this

day and because of the diligence of Local 104 members, a major incident was avoided.

I commend these members for following the appropriate grounding procedures and being their Brother's keeper. We can now understand the importance of grounding, not only to protect from induction, but also to protect from accidental energization. The cause of the incident was out of the members' hands, but we still need to protect ourselves from the unforeseen.

These procedures work and the proof lies with this group, who decided not to cut corners or be complacent in their work practices and went home to their families. And, as a result, the utility has taken a long hard look at their tagging procedures and added an additional layer of communication to avoid these types of situations in the future.

I would like to welcome JCR Construction employees to IBEW Local 104. You have made the right choice for yourselves and your families. I look forward to working with all of you and continuing this successful relationship.

Also, there is a new venue for the annual Rodeo and Outing. The new venue will be at Kimball Farm in Westford, MA. Climbing and activities will start at 11 a.m. on May 18, 2019. I hope to see you there.

As always, the monthly Union meeting is on the third Thursday of the month at all three locations. I will see you there.
